DAY10 AUG/27	SA	Xian → Beijing	Beijing served as the capital of 5 dynasties over a period of 800 years with each emperor identified as a dragon sent from the heaven. Start your city tour with a visit to the Forbidden City . This complex, the largest and most intact conglomeration of ancient structures of the imperial palace ever built in the world, features more than 800 buildings with 9999rooms, resplendent golden-glazed roofs, red lacquered pillars and vermilion walls. 5. I will conduct myself in a professional and courteous manner at all times and to remember that as a participant, I represent the USCTF and the United States of America. I understand that the Delegation Leaders, Team Leaders and Team Coaches are authorized to dismiss team members from the team who do not follow reasonable commands and instructions and/or showing disrespectful conduct to the officials of the USCTF, 3rd International Taijiquan Competition organizers, judges, and athletes.
